2	21B Container Rd	21A, B, C	W of CR150 along Container Rd, S to AllCr, N to Rocky Creek.
3	22 Bar Pit Rd	22, 23	W of Cr150 to Rocky Crk, W of the Old Rd to 21C.
4	25 A	25A, B	Property on the W side of the Campbell Landing Rd, all property in the corner joining the Adams property. Property east of the Campbell Landing Rd to CR150, S to Handicapped Zone.
5	26 A	26A, B	SW along Rocky Creek Rd, S to Rocky Creek, N to SRWMD property line
6	27 A	27A, B	N side of Center Rd to swamplines in block and/or SRWMD property line.
7	28	28	Property W of Center Rd to swampline.
8	30	30	Each side of the Dam Rd, S to swamplines, N to river, W to SRWMD property line.
9	33 A N-S Rd Gate	33A, B	Along N-S Rd to swampline N of tractor shed, W to swamplines, E the N-S road.(rd. 17 side of N-S road)
10	33 D N-S Rd. gate	33 D, 20B	N of Federal Rd #1 to Alligator Creek, W of 34 to CR 150
11	34 East Rd1	34	N of Federal Rd #1 to Alligator Creek, all of Zone 34.
12	35 Rd. 18	35	Along each side of Rd 18, W to N-S Rd., N to Federal Rd
13	37 Wolfolk Rd. Inter.	36, 37, 38	N of Federal Rd to Alligator Crk, S to across from Rd 99
14	39 A Rd. 99 Gate	39A, B	Road 99 flaggings A & B S of FEDERAL RD. #1, W to creek.
15	39 C	39C, D	Rd 99 & Rd 100, W of creek on Rd 99 to end of property.
16	40 A East Rd2	40A, B	W to Jones Mill Creek, N to Alligator Creek, E of Federal Rd, S to end of zone 40B.

Spring Gobbler Season:

Enclosed is the flagging information for spring gobbler season. We do not produce a map for the flagging just a set of descriptions. You will **need your 2021/22 fall flagging map and descriptions of the zones** in conjunction with these descriptions since the fall flagging is used as a reference. You will notice that there are only 25 flagging locations and honestly there will not be gobbling birds in even the majority of these. For that reason, we need to refrain from one membership flagging more than 1 zone. Additionally, it is helpful if “buddies” can hunt together in 1 zone or at least flag joining zones. These are only suggestions. Normally no more than half of the membership gobbler hunts. However, opening weekend of gobbler season is more crowded than deer season. Please refrain from riding around until at least 11 am. Just before season, please scout with the least interference possible. **Remember, no feed of any type eaten by turkeys may be placed on Club property from March 1 until after turkey season!** Please review the rules concerning turkeys.

In the past we have had some problems with members “chasing turkeys” from the county roads. They would call from the roads, going from zone to zone. This is the same as hunting in an unflagged zone. If someone is set up hunting the turkey and a member calls from the road, the hunt is ruined. **It is imperative that a member goes to the flagging location of a zone and check before any activity occurs, including calling of any type.** Also, although it is not a rule, restricting calling will make everyone’s hunting more productive. Hunting pressure and overcalling will make the gobblers go “silent” and almost impossible to kill.
